The saving, if any, after meeting the recurring and non-recurring expenditure and contribution to developmental, depreciation and contingency funds, will be further utilized for promoting the School and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manger of the School have individually gone through the provisions contained in the affiliation and examination byelaws and the circulars issued by the provisions contained in the affiliation and examination byelaws, directions, issued from time to time and law of the land.
8. That the School will ensure compliance of all statutory requirements like EPF, ESI and labour laws etc. with respect to the School and Staff of the School.
9. That the School will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygienic Safety certificates are being issued or renewed by the concerned Municipal or the State Authorities from time to time as per the prescribed term.
10. That the School will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before commencing the classes.



12. That the school will follow the provisions related to fee contained in affiliation byelaws and will disclose the details of the fee to the student/parents every year before starting of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce any student/parents to buy books/stationary/uniform from any particular shop.
14. That the school shall strive to make efforts for conservation of environment.
15. That the school will ensure that the school fulfils all essential requirement before applying for affiliation and will fulfil all other conditions post affiliation comply with all the general rules as given in the affiliation bye-laws or notified time to time.
16. That in case affiliation has granted with certain conditions, the school will not start CBSE Patter classes without submitted a Certificate/affidavit to the effect that the school has completed with all the conditions imposed by CBSE and the post affiliation conditions contained in affiliation byelaws along with general rules.
17. That the state pattern classes IX to XII running prior to the affiliation to CBSE would be sponsor for the State Board Examination. State Pattern Classes IX to XII will be closed in a phrased manner. No admission will be taken in the State Board Pattern Class IX to XII after getting affiliation from CBSE. The State Board School will be discontinued after switchover to CBSE.


