

2. It will be compulsory to teach Punjabi in your school up to 10th standard and CBSE New Delhi will make it compulsory to take Punjabi examination in such schools and at the same time it is said that in case of non-compliance. The No Objection Certificate will be withdrawn immediately.
3. The School Management Education Department would strictly abide by the notification issued by the Punjab Government under the RTE Act 2009 and the rules of the RTE Act 2009 framed for the State of Punjab.
4. After taking affiliation with CBSE New Delhi, the management of the school would be committed to pay the salaries and other allowances of the teaching staff and non-teaching staff of the school through pay cheque like government employees. At the time of school extension/update, as per the instructions of the government, the reserve fund of teaching and non-teaching staff would be deposited with the concerned District Education Officer. Failure to do so will result in immediate withdrawal of the No Objection Certificate.
5. You and your management will ensure that whenever any information is requested from your district education officer or a senior official of the education department, he /she will be provided with the required information as well as the required support. Failure to do so will result in immediate withdrawal of the No Objection Certificate.
6. The conditions for issuance of Child Safety, Public Health Sanitation and other No Objection Certificates will be scrutinized by the Punjab Government officials.

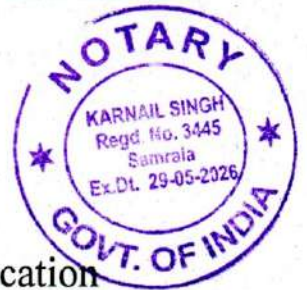

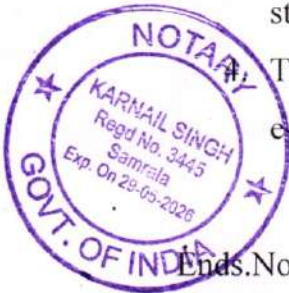
